TERMS AND CONDITIONS AS OF 01-09-2018

The purchase or reservation of any travel services offered by Barinca Travel & Tourism represents your acceptance of Barinca Travel & Tourism Terms & Conditions set out herein. Please ensure that you read carefully and understand these Terms & Conditions prior to confirming your booking

These General Terms and Conditions govern the contractual relationship between you and Barinca Travel & Tourism in respect of the package trips and other travel services we offer.

A package trip is defined as such when we arrange transport plus accommodation or another tourism service for a total price and the trip lasts for at least 24 hours or includes an overnight stay.

A contract is concluded once Barinca Travel & Tourism has accepted a booking you have made in writing (letter, e-mail or via the Internet).

Barinca Travel & Tourism and its agents and suppliers, in making arrangements for hotels, tours, meals, transportation or any service in connection with the itineraries of individual customers, shall not be liable for injury, damage, loss, accident, delay or irregularity, liability or expense to person or property due to act of default by any hotel, carrier or other company or person providing services included in the tours.

Furthermore, Barinca Travel & Tourism and its agents and suppliers accept no responsibility for any sickness, pilferage, labor disputes, machinery breakdown, government restrains, acts of war and/or terrorism, weather conditions, defect in any vehicle of transportation or for any misadventure or casualty or any other causes beyond their control.

Under no circumstances will Barinca Travel & Tourism or its agents, affiliates, service providers, suppliers, and/or distributors be liable for any of the following losses or damage (whether such losses were foreseen, foreseeable, known or otherwise): (a) loss of data; (b) loss of revenue or anticipated profits; (c) loss of business; (d) loss of opportunity; (e) loss of goodwill or injury to reputation; (f) losses suffered by third parties; or (g) any indirect, consequential, special or exemplary damages arising from the use of Barinca Travel & Tourism regardless of the form of action.

RESERVATION, CANCELLATION AND OTHER POLICIES

RESERVATION: A non-refundable deposit of 1000 euro for groups or 10% of the total estimated price for individuals is due with your reservation. Full balance of payment must be received by Barinca Travel & Tourism, no later than 60 days prior to the start of tour dates. Barinca Travel & Tourism reserves the right to cancel the reservation if payment is not received by this time.

Upon receipt of the first deposit you accept our Terms & Conditions. After that, you will receive a confirmation of reservation by E-mail.

PAYMENTS: The tour price is payable to Barinca Travel & Tourism. Depending on the means of payment, there may be an extra charge to cover transfer costs. Failure to pay in time entitles Barinca Travel & Tourism to cancel your booking without notice and without refund of the deposit. Prices are quoted in Euros and per person.

CANCELLATIONS: If you need to cancel a reservation, please do so in writing (best by e-mail). If we receive your cancellation notice sixty (60) to thirty-one (31) days prior to the departure date, we will retain fifty percent (50%) of the tour price, not including the deposit. If we receive your cancellation notice thirty (30) days or fewer prior to the departure date, we will retain one hundred percent (100%) of the tour price.

The tour price is quoted as a package. No partial refunds or credit will be given for services not used. We recommend that you obtain travel insurance upon booking.

PACKAGE PRICES: Package prices are based on ground costs. Barinca Travel & Tourism tries its utmost not to increase tour prices (in full or part), however sometimes increases are outside its control. We reserve the right to amend tour prices (or any part) without notice at any time before and including the departure date. Amendments may be necessitated for many reasons including, but not limited to increased fuel costs, toll road charges, increased taxes etc.

EXCLUSION FROM TOUR PRICE: The following items are excluded from the tour price: *visa, passport and vaccination charges; *departure, airport and airline taxes; *extra meals not included in the itinerary; *laundry, postage, personal clothing, medical expenses, personal travel insurance and items of a personal nature; *emergency evacuation charges; and *tips and luggage charges.

APPLICABLE LAW AND PLACE OF JURISDICTION: The contractual relationship between you and Barinca Travel & Tourism is subject to French law. Carcassonne is the sole place of jurisdiction for any disputes arising.
